SECTION 3 – APPLICATION TERMS AND CONDITIONS

1. GENERAL

- 1.1. These terms and conditions (the “**Terms and Conditions**”) relate to your application to take part in the television programme “Remotely Funny” (Series 2) (“**Programme**”), which we, Twenty Twenty Productions Limited, propose but do not undertake to produce for the BBC “**Broadcaster**”). By applying to take part in the Programme, you and your parent(s)/guardian(s) agree to and shall comply with these Terms and Conditions.
- 1.2. We are looking to choose children and their families to appear across the series that are different characters in terms of personality, age, ethnic background, gender and ability, from all areas of the UK, both to represent the audience and to maximise the interest in the show by the audience. We will consider everyone who applies equally, but cannot guarantee that everyone will be successful. Our decisions regarding the selection process and/or suitability of applicants are entirely at our discretion and are final and there will be no right of appeal against any decisions taken by us on this matter. Unfortunately, due to the large number of applications we receive, we will only contact you and your parent(s)/guardian(s) if you are successful in being selected as a potential contributor for the Programme.
- 1.3. You accept that receiving an application form, a phone call from a member of the Programme production team, and/or attending an interview DOES NOT automatically mean that you will be appearing in the Programme and we reserve the right, at our sole discretion, to stand you down at any time during the production process, even if you have been given a date to attend auditions or take part in the programme.
- 1.4. You understand that we reserve the right to vary any element of the Programme and, even if you meet the Eligibility Requirements outlined below, we shall have no obligation to produce any episode of the Programme, that any episode of the Programme will be broadcast, or that we will select you as a contributor, and even if you are selected we are not obliged to include your contribution in the Programme.

2. ELIGIBILITY & OTHER REQUIREMENTS

- 2.1. By submitting your application to take part in the Programme you and your parent(s)/guardian(s) confirm that (unless otherwise agreed with us) you meet the following requirements (“**Eligibility Requirements**”):
 - 2.1.1. You are between 8 and 13 years old as of 1st September 2016;
 - 2.1.2. You are a permanent legal resident in the UK; and



2.1.3. Neither you nor a member of your household or immediate relative (i.e. mother, father, brother or sister) are employed/have ever been employed by us and/or the Broadcaster in the last twelve months.

2.2. Participation in the Programme will be subject to:

2.2.1. you and your parent(s)/guardian(s) having sufficient broadband speeds; and

2.2.2. all consents being obtained and, where required a performance licence (which may require without limitation consent from your school and/or local education authority). You and your parent(s)/guardian(s) agree to provide us with any assistance or further information necessary to do this'

2.2.3. if requested, such background checks as we reasonably request, which may include criminal records (unspent) checks, accessibility and/or other requirements, and/or health, allergies and/or medication disclosures.

2.3. You and your parent(s)/guardian(s) must be able to commit to all of the production/filming days required (including rehearsals) which are currently expected to be between 27 July 2017 and 18th August 2017 (inclusive) (but may be subject to change).

3. YOUR OBLIGATIONS

3.1. You and your parent(s)/guardian(s) confirm that all of the questions in this application form have been fully, honestly and accurately completed and neither you nor your parent(s)/guardian(s) have misled or attempted to mislead us in any way to their identity, experiences or health or in any other way and you and your parent(s)/guardian(s) agree to keep us informed of any changes to these circumstances or the information and/or data set out in this application form.

3.2. If you and your parent(s)/guardian(s) are found to have knowingly supplied inaccurate, misleading or false information, you and your parent(s)/guardian(s) may be **immediately** disqualified from casting process and/or taking part in the Programme.

3.3. You and your parent(s)/guardian(s) agree that you and your parent(s)/guardian(s) will not withhold from us any material fact that may in our reasonable opinion jeopardise or otherwise impact on the Programme or which might result in publicity adverse to our good name, the Broadcaster and/or the Programme.

4. INTELLECTUAL PROPERTY RIGHTS

4.1. If you are invited to attend any stages of the audition, selection and/or production process for the Programme and in consideration of one pound (and other good and valuable consideration sufficiency and receipt of which is acknowledged), you and



your parent(s)/guardian(s) agree to the photographing, recording and filming of your and your parent(s)/guardian(s) interview and/or audition (the “**Contribution**”) and the use of such Contribution (or any part(s) thereof) in the Programme.

- 4.2. You and your parent(s)/guardian(s) grant to us all necessary rights and consents to permit us to make the fullest use of the Contribution and/or any information, photographic/video material submitted by you and your parent(s)/guardian(s) as part of your application for and/or participation in the Programme (“**Material(s)**”) for any purposes connected with the production, promotion and/or exploitation of the Programme, and/or ancillary products, rights, services and/or in connection with us, and/or the Broadcaster, in any and all media now known or in the future invented throughout the world in perpetuity. You and your parent(s)/guardian(s) warrant that you have the necessary licences, rights and consents to authorise us to use the Materials in full or part in accordance with these Terms and Conditions.
- 4.3. You and your parent(s)/guardian(s) accept that we have the right to edit, copy, adapt and/or translate the Contribution and/or Material(s) as we see fit and you and your parent(s)/guardian(s) irrevocably waive the benefits of and agree not to assert any provision of law known as "moral rights" or any similar laws of any jurisdiction.
- 4.4. You and your parent(s)/guardian(s) agree that you and/or your parent(s)/guardian(s) shall not be entitled to injunct or restrain the transmission or use of the Contribution and/or Materials, the Programme and/or any ancillary use which includes the Contribution and/or Materials (or any part).

5. **DATA PROTECTION**

- 5.1. All personal data will be kept secure and be held in accordance with the Data Protection Act 1998 (“**DPA**”).
- 5.2. You and your parent(s)/guardian(s) grant to us any and all consents necessary (including, if applicable, your express consent in respect of sensitive personal data including medical, ethnic origin and/or racial information disclosed in connection with the casting and/or Programme) pursuant to the DPA to store, handle and/or process your and your parent(s)/guardian(s) personal data and, if applicable, sensitive personal data, in any form (electronic, hardcopy or otherwise) for the purposes of:
 - 5.2.1. in selecting potential contributors for the Programme;
 - 5.2.2. enabling us to develop, produce and exploit the Programme, and may even be detailed in the Programme itself;



5.2.3. as may reasonably be necessary for the effective running of our business and the transfer of such personal data outside of the European Economic Area (where data protection and privacy regulations may not offer the same level of protection as those in the European Economic Area) and/or sharing it with relevant third parties for the purposes of the production and exploitation of the Programme and/or Contribution including the production team, Broadcaster, and/or our insurers and distributors; and

5.2.4. in order for us to comply with any and all of our obligations under applicable laws (including for the purpose of complying with data subject access requests).

This does not affect our obligations and responsibilities under the DPA and/or your and/or your parent(s)/guardian(s) rights as a data subject, save that it is agreed that use of any audio and/or visual material relating to the casting and/or selection process and/or Programme that are made available to you and your parent(s)/guardian(s) as a result of a subject access request, are restricted to our premises only.

5.3. If you are not selected as a potential contributor and you and your parent(s)/guardian(s) have indicated that you and your parent(s)/guardian(s) do not wish to be contacted about other programmes or projects, then your information will be deleted by us after a reasonable amount of time.

5.4. If at any point you and your parent(s)/guardian(s) decide that you and your parent(s)/guardian(s) no longer want us to hold, use or process any of your and your parent(s)/guardian(s)' personal information or want to update your contact details, please let us know.

6. CONFIDENTIALITY

6.1. You and your parent(s)/guardian(s) will keep **strictly confidential** and will not without our prior written consent at any time publish or disclose to any person (including without limitation via the internet or any social networking sites such as Facebook or Twitter) any conversation, information, materials or photographs concerning the Programme, other persons and/or the application/selection process which comes to your and your parent(s)/guardian(s) knowledge as a result of your participation in the casting process and/or (if selected) the proposed Programme nor other information relating to us, Broadcaster or the Programme acquired by you and your parent(s)/guardian(s) other than information already in the public domain.

7. MISCELLANEOUS

7.1. A reference to "include" or "including" shall mean without limitation to the foregoing.



- 7.2. The rights granted under these Terms and Conditions are freely assignable, transferrable and licensable by us.
- 7.3. You and/or your parent(s)/guardian(s) shall do all things and sign all further documents and/or agreements as may be required by us and/or Broadcaster including to vest in and/or further confirm the rights expressed to be granted to us by you and/or your parent(s)/guardian(s) under this Agreement; undertaking background checks and/or verifying any information provided to us and/or handling of sensitive personal data.
- 7.4. You and/or your parent(s)/guardian(s) acknowledge and agree that neither us, and/or Broadcaster nor our assignees and/or licensees shall be liable for any loss, damage, injury, claim or disappointment suffered, by you and/or your parent(s)/guardian(s) (including but not limited to special or consequential loss, trespass to property or trespass to person) in connection with your and/or your parent(s)/guardian(s) participation in Programme's application/casting process and/or the Programme, other than death or personal injury caused by our or the Broadcaster's (as applicable) negligence or other liability that is prohibited from being limited or excluded by law.
- 7.5. Failure by us to take action in respect of the breach of any provisions of these Terms and Conditions shall not be interpreted as constituting a waiver by us of the right to take action in future in respect of such a breach.
- 7.6. These Terms and Conditions will be exclusively governed by and construed in accordance with the laws of England and subject to the exclusive jurisdiction of the English courts.
